III. GENERAL CONDITIONS

2. GENERAL

2.1 This Event will count towards:

- The 2010 FIA European Rallycross Championships for Drivers
- FIA Rallycross Nations Cup

3. DESCRIPTION OF THE CIRCUIT

Place: Padronelos - Montalegre

Telephone: +351968027964

Length: 1.050 m. With JOKER-LAP: 1.150 m;

Width of Start: 16 metres

Maximum width: 16 metres

Minimum width: 16 metres

Location: The municipality of Montalegre is placed in the extreme north of Vila Real's district, 100 Km away from Vila Real and 150 Km from Porto (using high-way or national road). It is 20Km away from Spanish border along national road until Galiza's high-way.

6. ENTRY FORMS - ENTRIES

As the Entry Form from the Driver and the Confirmation of the acceptance from the Organiser is considered as a contract, the Driver, not coming to the Event, has to apologise giving the reason as soon as possible. The Entry Fee will be paid in cash (only) at the Administrative checking.

6.6 The maximum number of starters will be defined in the Supplementary Regulations. The maximum total number of starters for the support race will be 20.

7. ENTRY FEES

7.1 The entry fee is:

- a) 1st closing date of entries 100€ (all included)
- b) 2nd closing date of entries 200€ (all included)

8. INSURANCE

The entry fee includes the insurance premium, which guarantees the competitors' cover for Civil Responsibility towards third parties in € 20 000 000,00 or € 6 000 000,00, in corporal or material damages respectively, per accident

IV. CHECKING

11. SCRUTINEERING

11.3 **Noise:** for all cars, a limit of 100 dB is imposed.

11.8 Tyres

The fitting of heat retaining devices or pre-heating is prohibited. This applies both wet-weather and dry-weather tyres.

V. RUNNING OF THE EVENT

14. QUALIFYING

There will be 5 laps in the qualifying Heats.

15. FINALS

There will be 7 laps in the Finals.

16. GENERAL

16.6 Flag signals

If a black flag is shown in a heat, the driver has to go immediately to the paddock or such other place (to be specified); in a final, he has to go to the Parc Fermé or such other place (to be specified).

VI. PARC FERME – RESULTS – PROTESTS

20. PROTESTS – APPEALS

20.1 All protests will be lodged in accordance with the Code. All protests must be made in writing and handed to the Clerk of the Course or his assistant, or in their absence any of the Stewards of the Meeting, together with the sum of €500.

If the protest requires the dismantling and re-assembly of different parts of a car, the claimant must make a deposit of €2.000

20.5 Competitors have the right to appeal, as laid down in Articles 181, 182 e 183 of the Code and also as set out in the Rules of the International Court of Appeal. The amount of the appeal fee is €2.500.

VII. PRIZES AND CUPS

21. PRIZES

The podium ceremony on the circuit will be held immediately after the races. The winners of the 1st, 2nd and 3rd prizes must be present, wearing their race overalls. Failure to attend this ceremony and/or the wearing of inappropriate clothing will be penalized by the loss of any monetary award/benefit associated with the corresponding position at the end of the race.

The prize-giving will take place at the Auditorium Town Hall building at 18h30.

The prizes will be awarded in Euros.

22. FIRE EXTINGUISHERS

Each driver is responsible for ensuring that a single piece extinguisher of min. 5Kg. is available within his own team's area inside the paddock.

23. ENVIRONMENT POLLUTION

Each driver is requested to ensure that a plastic sheet (minimum dimensions 4 metres by 5) is spread on the ground in the place reserved for his team where work is to be done on his car, in order to prevent any pollution in case of an accidental leak, etc.

24. DRIVERS' LIAISON OFFICER

The Drivers' Liaison Officer will be recognisable by a waistcoat.
